JOB INFO makes no representations as to the suitability of any employer or job listed in this referral service for any potential employee. Any and all agreements and/ or conditions of employment, including but not limited to the following, are to be decided between the employee and employer: (a) type of job; (b) interests of job seeker; (c) qualifications of job seeker; (d) salary, benefits, and other conditions of employment; (e) location of job; (f) duration of employment.

No guarantee or warranty is made that the employer or employee will accept the subscriber when contacted. It is the sole responsibility of the subscriber, employer or employee to abide by the applicable state, federal laws governing employment or the collection of applicable taxes.
